CALL TO ORDER AND WELCOME

- The WAF 31 Organizing Committee is Cathy Metherell, Dan Barnett, Sharon Axelrod, Leslie Stone, Dave Piatt, John McClellan (Happy Wanderers), Alice Lawrence (Suncoast Sandpipers) and Robin Kelly (Suncoast Sandpipers)

There are scheduled to be four walks and a swim. They will be in:

- o Tavares—5 and 10K walks; and the swim
- Leesburg—5 and 10K walks
- Eustis—5 and 10K walks
- Mt Dora—5 and 10K walks

We are currently finalizing the walks and will require some club members to pre-walk these events to ensure we have the instructions correct. We are looking for volunteers!

Proposed Changes to the Constitution

Change #1

Article V Section 1. Annual dues shall be paid by all members on a fiscal basis, dues being payable by the beginning of the fiscal year. First time members paying dues other than at the beginning of the fiscal year will pay a prorated amount.

Proposed Change- Delete the words "First time"

Change #2

Article VI Section 1c: Currently reads-

Elections shall be the first order of new business at the yearly general membership meeting. The membership present at the meeting shall elect new officers by a simple majority vote of members in good standing

Proposed Change- After the words "The membership present at the meeting "add the words "and those not attending who have filed a proxy vote with the President or Secretary prior to the meeting"

Change #3

Article VI Section 2d: Currently reads-

A decision of the Board of Directors may be overridden only upon a vote of 2/3 of those eligible voting members present at a general membership meeting or from those not present but who have filed a proxy vote with the President prior to the meeting.

Proposed Change- add the words "or Secretary" after the word "President" in the last sentence.
